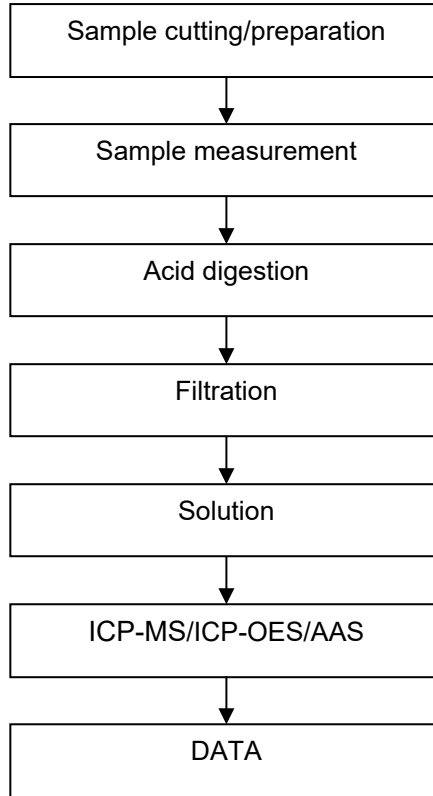

Elements Testing Flow Chart



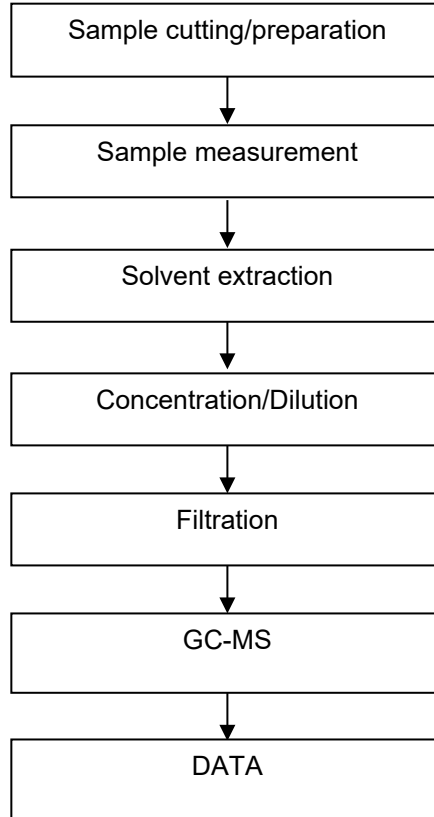

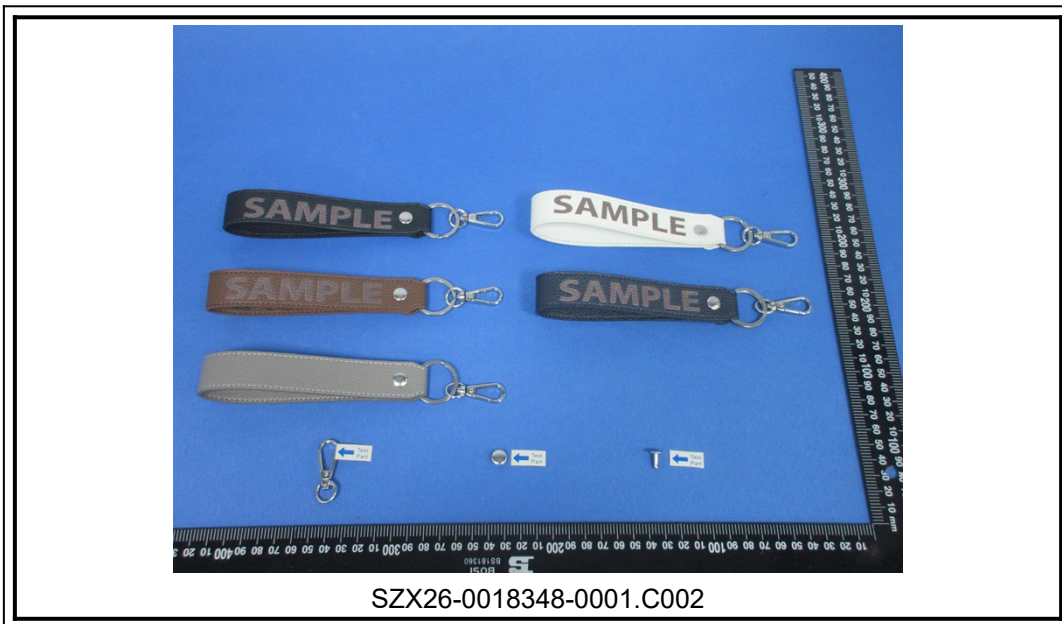

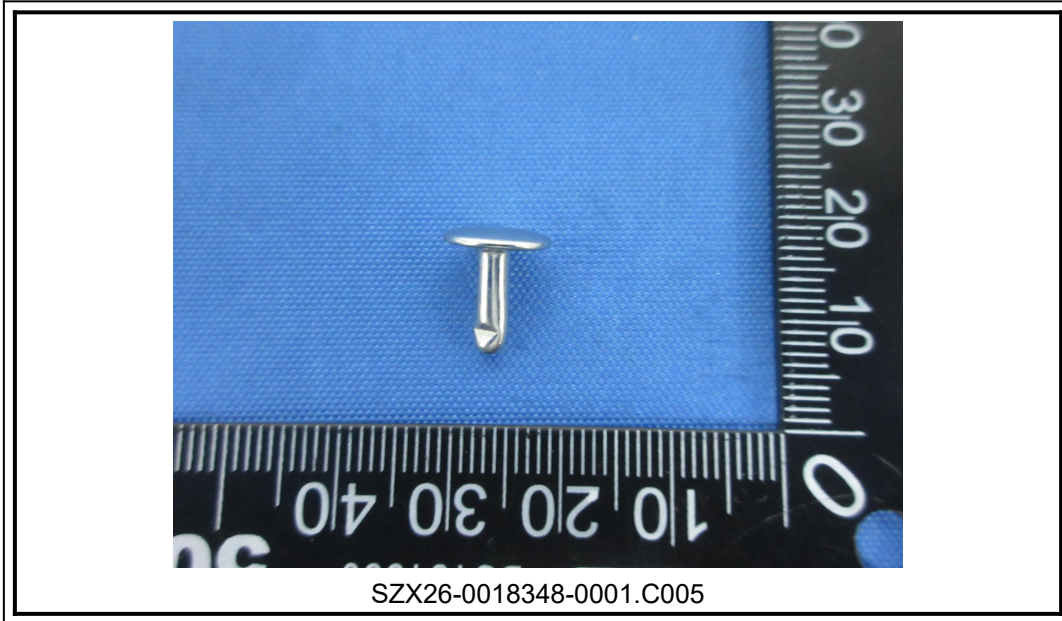
